**Hoosiers for Life promotes the protection of innocent human life from conception to natural death.** This includes abortion, end of life, adoption, and all other aspects.. We assume the biblical, philosophical, and scientific wisdom that an unborn baby is a baby from the moment of conception, created in the image of God.

Hoosiers for Life is the only anti-abortion organization to construct and promote legislation to protect innocent human life in the state of Indiana. As a non-profit, non-partisan single issue advocacy organization we fight relentlessly to ensure politicians support our strong legislation. We work to educate and inform grassroots individuals all over the state about lawmakers actions for or against our measures.

We stand against the culture of death and stand in the gap for the victims of the abortion industry. We present strong legislation, pressure legislators, educate voters, and are a constant example for others who desire to end the killing of children.

H4L is the author and main proponent of the **Preemie Law** that is currently being drafted in other states. Indiana was the first to pass this bill that gives life-saving care to premature babies. Hospitals no longer can refuse care due to age of birth. It allows care to infants prior to Roe v Wade's age of "viability" and causes states to defy Roe's denial of the value of babies born earlier than 24 weeks. This bill is now gaining traction in other states.

H4L constructed the "**Sanctity of Life**" amendment. This measure defines human life and reinstates it into state law giving the legislature the ability to protect the posterity of the state and claim state sovereignty on behalf of preborn babies.

We write and promote state legislation to make abortion illegal. The **Protection of Life bill** has been authored in the state of Indiana for the past five years and is gaining support all around the country. Eleven states have since used full or partial elements of our bill within their state legislatures as well.
