

Dear Elected Official,

I, _____, a Hoosier resident and one of your constituents, am very concerned with election integrity in the State of Indiana. I was made aware of the work of a volunteer group that began gathering extensive data on several of the previous elections and after reviewing their work that can be found at www.IndianaFirstAction.com, I was overwhelmingly convinced that a change has to be made in the administration of Indiana's elections. I would sincerely ask that you review this data with an open mind.

After such review your constituents deserve an answer and an action response on your part that no such lack of election integrity will be allowed to continue in the State of Indiana. In short, what are you going to do to fix this mess? As their website shows, there is no transparency, no accountability, and no consistency throughout the state (in the means and methods of holding said elections), leaving us citizens to simply accept that the "safe and secure" message is clearly not the truth. Frankly, its insulting for anyone to suggest that our elections are perfect. They are not. Its a broken and irredeemable system.

I want to know that my vote was counted as it was cast. The only true ballot measure that is safe and secure is to return to paper ballots, hand counted at the precincts, where I, a citizen of Indiana, can participate in the process of elections. Recently, Arizona Majority Leader Borrelli wrote all Arizona clerks after passing Senate Concurrent Resolution 1037 and stated, "The federal government has made it very clear that elections equipment is considered a target by those who want to threaten the safety and security of our country. We have long ignored this elephant in the room by allowing electronic voting systems made with parts produced in countries considered adversaries to the United States to be used as the primary method for conducting our elections. It is in our state's and nation's best interest that we comply with implementation of security measures to protect our republic." Arizona has it right. Let's follow.

This isn't a Republican or Democrat issue, but it is a fundamental issue in securing the confidence of the electorate of those you are to govern.
